## Põhiseadus



Paraku nähti seejuures hunti seal, kus hunti ei ole. Põhiseaduse Assambleel kardetud kandidaatide ümber puhkevat võimalikku poliitilist "lehmakauplemist" tuleb pidada väikeseks paheks võrreldes praeguste telgitaguste läbirääkimistega. PS § 1 lõikes 1 sätestatud demokraatia printsiip nõuab riikliku tahte kujundamise, sealhulgas personaalsete valikute läbipaistvust. Kui kodanik ei saa teada, kes kellele ja mida lubas, et soovitud isik soovitud kohale "upitada", ei toimi parlamendi avalikustamise funktsioon ega saa demokraatia nõuetekohaselt funktsioneerida. 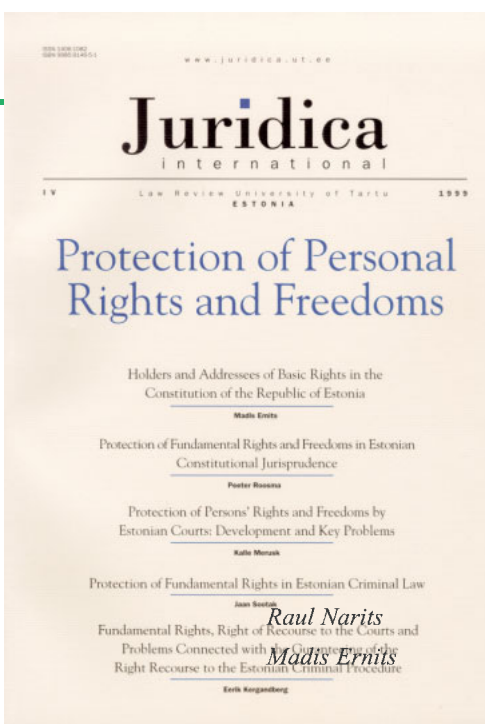

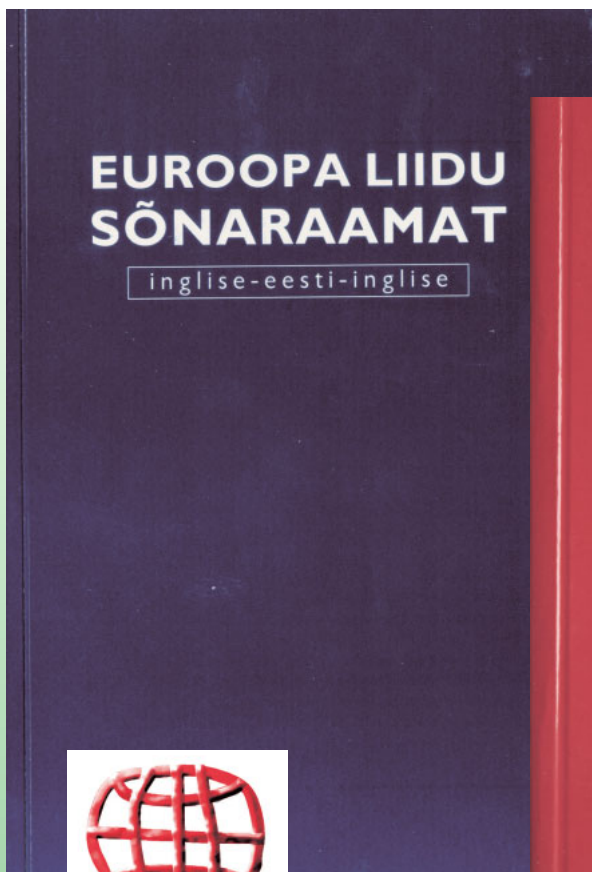
